Founded in summer 2014, Small Business United is focused on uniting small businesses within a six-county service area through investing in United Way of North Central Florida. Through this investment, small businesses support United Way's mission and programs, including the Community Investment Fund which supports local nonprofit programs. Since its inception, small businesses have raised over half a million dollars for our community.







## AFFORDABLE PHILANTHROPY

Small Business United offers three levels of partnership starting with annual commitments of \$600 (or \$800 in-kind), \$1200, or \$2400 per year, with the convenience of auto-payment and the option to amortize payments monthly.

Partners can also choose to enroll as "Evergreen" ensuring their partnership is renewed automatically.
